

**Memorandum of Understanding  
Between  
Kaveri University  
And  
BioAgri Input Producers Association (BIPA)**

**Preamble**

This Memorandum of Understanding (MoU) establishes a framework for collaboration between Kaveri University, located at [Address], and the BioAgri Input Producers Association (BIPA), located at [Address], hereinafter referred to collectively as "the Parties." This MoU reflects the Parties' mutual desire to promote cooperation in research, education, and student skill development, recognizing their shared commitment to advancing joint activities in these areas.

**Areas of Cooperation**

The Parties agree to explore and engage in the following collaborative activities:

1. **Collaborative Research:** Undertake joint research projects in mutually agreed-upon fields to advance knowledge and innovation.
2. **Industry Expertise in Academia:** Facilitate the participation of qualified BIPA industry associates as visiting lecturers or professors at Kaveri University to enrich the educational experience.
3. **Joint Events and Programs:** Collaborate in organizing and participating in conferences, symposia, workshops, and instructional programs that benefit both institutions.
4. **Academic Resource Sharing:** Exchange academic materials, publications, and information to support teaching, learning, and research endeavours.
5. **Curriculum Development and Skilling:** Cooperate in developing curricula and enhancing student skill sets to better align with industry needs and standards.

**Financial Arrangements**

This MoU serves as a statement of intent and does not, by itself, entail any financial obligations for either Party. Any financial commitments arising from specific collaborative activities will be negotiated and detailed in separate agreements, subject to the regulations and funding availability of each institution.

**Implementation and Further Agreements**

For each collaborative activity initiated under this MoU, the Parties will engage in good-faith discussions to develop comprehensive agreements outlining the terms and conditions. These agreements will address, among other aspects:

- Scope of work and objectives
- Funding arrangements
- Roles and responsibilities of each Party
- Intellectual property rights
- Confidentiality provisions

**Legal Status**

This document is a non-binding Memorandum of Understanding and does not create any legal or enforceable rights or obligations between the Parties. Implementation of any activities described herein will require the execution of separate, specific agreements that will delineate the scope, responsibilities, and rights of each Party. The Parties commit to pursuing these agreements in good faith to foster a productive and collaborative relationship.

**Duration and Termination**

This MoU will remain in effect for a period of 5 years, commencing on the date of the last signature. Either Party may terminate this MoU by providing one month written notice to the other Party. Termination of this MoU will not affect the validity or duration of any separate agreements entered into pursuant to this MoU, unless otherwise stipulated in those agreements.

**Amendments**

Any amendments to this MoU must be made in writing and signed by authorized representatives of both Parties.

**Governing Law**

This MoU shall be governed by and construed in accordance with the laws of Telangana region.
